**Parade Information:**

We will be lining up vehicles at the Carver County Court House Parking Lot. There will be a Jaycee member with the map of the parking lot to let you know where your number is at the entrance of the parking lot.

Lining up for the parade is at 12pm and the parade will start at 1pm.

If your group is handing out candy, we ask that you have individuals walking along side your car, truck, float, and etc. We don't want candy being thrown from the vehicle.
